### **INFORMATION ON THE BAIL SCHEDULE**

The following schedule is the presumptive bail to be set when an individual is placed in custody for a criminal offense in San Benito County. A judicial officer may set bail at an amount different than the bail schedule in any individual case. In doing so, the judicial officer shall consider the factors in Penal Code section 1275 such as the protection of the public, the seriousness of the charged crimes, the previous criminal record of the defendant and the probability the defendant will appear in court.

Questions concerning the application of this bail schedule to any particular arrestee may be made to the Presiding Judge or designee during court operation hours. After work hours, the ON CALL DUTY judge is available through the San Benito County Dispatch.

For crimes, <u>not</u> listed on the schedule, the presumptive bail for each is \$10,000 for felonies and \$6,000 for misdemeanors.

#### Bail Stacking – Arrests for More Than One Crime

Arresting agencies and detention facilities are directed to follow these guidelines when booking persons for more than one crime and/or warrant.

- 1. When a person is booked on two or more crimes, the bail shall be set at the crime with the <u>highest</u> bail amount.
- 2. When a person is booked on two or more crimes that are either "serious felonies" as defined in Penal Code Section 1192.7(c) and 1192.8 or "violent felonies" as defined in Penal Code Section 667.5(c), the bail amounts for each separate crime shall be added together.
- 3. When a person is booked on a crime or crimes and has outstanding warrants, the warrant amounts shall be added to the schedule bail amounts.

#### Enhancements, Aggravating Factors & Special Allegations

**ENHANCEMENT (ENH):** An Enhancement is a fact related to a specific charge. In order to determine the correct bail amount for the charged offense, first determine the bail amount for the charged offense and each enhancement for that offense. Then add the bail amount for the charged offense plus each related enhancement. The totaled amount constitutes the proper presumptive bail for that charge.

<u>AGGRAVATING FACTOR (AGGF)</u>: An Aggravating Factor, like an enhancement, is also a fact related to a specific charge. Aggravating factors are to be treated the same as enhancements when calculating bail.

<u>SPECIAL ALLEGATION (SA)</u>: A Special Allegation is a fact related to the defendant rather than a particular charge. In order to calculate the proper bail amount for special allegations, simply add the specified bail amount of each special allegation to the underlying charge to calculate bail.

#### **Bail Amounts on Arraignments in Court**

At first appearances and arraignments in court, the judicial officer may exercise discretion to lower or raise bail based on the actual charges filed by the District Attorney, and on enhancements, aggravating factors and special allegations.

#### Jail "OR" Policy

### A. Inmates that meet the following requirements may be released on their own recognizance "OR" after booking.

- 1. Able to understand the condition of the OR release agreement and agree to sign the agreement to appear in court.
- 2. Provide formal identification (i.e. California ID card, Driver's License or Matricula Consular card) or if jail employees are able to establish identification through a prior booking photograph, personal recognition or positive identification from the DOJ fingerprint identification printout.
- 3. Able to provide a residence address in the State of California
- 4. Bail of \$5,000 or less, without judicial approval

### B. All persons arrested for fresh misdemeanor charges fresh and misdemeanor warrant arrests are eligible for release, except for the following:

- 1. Penal Code charges: 166(c) or 166(c)(2), 243(e)(1), 273.5, 273.6, 646.9, 647.6 or any misdemeanor charge occurring with 2 days of a prior arrest.
- 2. Persons arrested for violations of Vehicle Code 23152(a) and 23152(b) with one or more prior convictions for 23152(a), 23152(b), or 23101/23103.5 within 10 years of the date of new offense.

### C. Intoxicated inmates shall remain in custody until sober unless there is a responsible adult to whom the inmate can be released.

- **D. Probation Violations:** Individuals arrested for violation of Probation Department supervised misdemeanor or felony probation shall be held on a "No Bail" status unless a bail amount has been set by warrant or other court order.
- E. Criminal History Check (CJIS): The booking person shall complete a criminal history check to determine if the inmate may be released on OR.
- F. Multiple or "NO OR" Warrants: No subject shall be released OR when arrested on three or more warrants. No inmate shall be released OR when the warrant states "NO OR, Body Only, not to be released without posting bail" or similar language.
- **G. Dangerous & Non-Dangerous Defendants:** Notwithstanding the above, whenever the booking officer or other jail staff has information suggesting the defendant presents a danger to the community, jail may refuse to release the subject OR and the subject shall be held subject to the bail schedule.
